



Student Protection Plan

In addition, the plan addresses minor inconveniences like lost or delayed baggage. **Benefits include:**

Up to 100% of Tuition & Trip Cost	Trip Cancellation: provides reimbursement in the event you are forced to cancel the trip for covered reasons.
Up to 100% of Tuition & Trip Cost	Trip Interruption: provides reimbursement in the event you cannot continue on the trip for covered reasons
Up to \$500/(\$200/DAY)	Trip Delay: covers additional accommodation, meal and local transportation expenses if delayed (for 12 hours or more) by inclement weather, strike, common carrier delays and other covered reasons.
Up to \$1,000	Baggage Protection: reimburses replacement of baggage and personal property that is lost, stolen or damaged
Up to \$300	Baggage Delay: provides reimbursement for the purchase of personal effects while waiting for luggage delayed 24 hours or more by a common carrier.

Up to \$10,000	Accident & Sickness Medical Expense: provides reimbursement for emergency accident and sickness medical expenses incurred during the trip.
Up to \$100,000	Emergency Evacuation: covers medical transportation expenses if an accidental Injury or sickness takes place during the trip. Transportation may include being taken to the nearest hospital where appropriate medical treatment can be obtained and/or transportation to your home States for further medical treatment.
24-HOUR/7 DAYS	Non-Insurance Worldwide Emergency Assistance Service: provides emergency hotlinefor travel and cash transfer emergencies.
