We further understand that NSLC will post all important updates on myNSLC (after February 1) and it is our responsibility to check this site on a regular basis.

We understand that applications from qualified students are processed in the order received and that applications may exceed available spaces. We understand that spaces are limited and we may be placed on a waitlist. We understand that this is an application for participation in the Program and enrollment is contingent upon approval by NSLC at its discretion. If not accepted, all money paid will be returned.

We understand additional required forms must be signed in order to participate in the NSLC. These forms be available on the myNSLC portal. Login information will be sent to the email addresses listed on page one upon acceptance to the NSLC.
